General Guidelines for ISEE Awards

- 1. The Evaluation of ISEE awards will be based on two major criterion
 - A) 25 % weightage will be given for Contribution to ISEE,
 - B) 75 % weightage will go to biodata and other related contributions.

The criterion like number of membership mobilized for ISEE, Number of papers reviewed for IJEE, funds generated for ISEE, number of GB attended and contribution in GB, number of ISEE Seminars attended during previous 10 years etc. will be judged towards the contribution to ISEE.

- 2. To apply for any of the awards, it is mandatory that the prospective applicant must have attended at least three National Seminars out of the last Five National Seminars.
- 3. A candidate receiving any award must have observed a cooling period for at least two National Seminars/ years before applying and to be considered for another ISEE award.
- 4. The minimum period of membership of ISEE for all the ISEE awards is must. ISEE Young Scientist and Best KVK Scientist it is a minimum of three years, whereas for all other awards one should have not be less than 10 years old member.
- 5. Any individual having Master or Doctoral degree in Extension Education can become an ordinary or life member of the society by paying fee determined for the purpose. However, Ordinary membership is open for all interested in the field of extension education. Ordinary membership is valid for one year only. To continue their membership, ordinary members have to get it renewed on yearly basis.
- 6. All the awards will be given in National Seminar in persona. In case any recipient fails to reach in National Seminar to receive the award, the candidature for such recipient will be rejected. In no case the candidature in absentia will be considered.
